ADMISSION CRITERIA

Students attending Tulsa Public Schools or Union Public schools and enrolling under the EXCELerate Concurrent pilot program must meet the following criteria for concurrent enrollment admission:

- Students must be sophomores, juniors, or seniors and eligible to graduate from high school in the spring of their senior year.
- Juniors and seniors must participate in the American College Testing program (ACT or PLAN). Sophomores must participate in the PLAN or EXPLORE.
- Sophomores must have a PLAN score of 15 (or equivalent EXPLORE).
- Juniors must have a composite score of 19 ACT/PLAN or cumulative un-weighted high school GPA of 2.5.
- Seniors must have a composite score of 19 ACT/PLAN or cumulative un-weighted high school GPA of 2.5.

**Note – the above criteria is for Admission requirements only. Refer also to Enrollment criteria below.*

Student must provide the following credentials to the Enrollment Services Office on the campus of attendance:

- Tulsa Community College Application for Admission
- EXCELerate Concurrent Enrollment Application with appropriate signatures
- Current official high school transcript (juniors and seniors only)
- Official ACT or PLAN scores (juniors and seniors only)

Please note: Admission to the institution does not guarantee eligibility for course enrollment.

ENROLLMENT CRITERIA

Students entering under the alternative admissions category through the TCC - Tulsa Public Schools & Union Public Schools EXCELerate Concurrent pilot program must meet the following criteria for enrollment in classes:

- Both juniors and seniors must be proficient in the area in which they wish to enroll. Students must have a 19 ACT or PLAN subject score in English, Reading, and/or Science Reasoning to enroll in those courses.
- Tulsa Community College requires that a student score a 20 ACT or PLAN subject score in Math in order to enroll in MATH 1513 (College Algebra). Additionally, students must have a 19 ACT or PLAN score in Reading to enroll in any other collegiate course. TCC's Computerized Placement Test (COMPASS) may not be used to meet the proficiency requirements for concurrent enrollment.
- Sophomore enrollment will be limited to a TCC Strategies for Academic Success or college readiness course, taught at the high school location.
- Enrollment for all concurrent students will not exceed 19 credit hours per long semester or 9 credit hours for summer. For purposes of calculating workload, one-half high school unit shall be equivalent to three semester hours of college work, excluding extracurricular electives.
- Concurrently enrolled high school students may not audit college courses.
- Students who receive a semester GPA below 2.0 will be placed on academic probation for one semester. Students on probation must earn a subsequent semester GPA of 2.0 in order to re-enroll.

A detailed explanation of Oklahoma State Regents' policy on concurrent enrollment is available from the Enrollment Services Office.

CE Tuition Waiver Scholarships for juniors and seniors are awarded as funds are available. Maximum award per student is (6) credit hours per semester for any combination of concurrent enrollment courses (EXCELerate and/or regular concurrent enrollment). Students must follow the EXCELerate program regulations and must enroll in at least one three-credit hour course
